Taylor Hart Limited provides an installation service for specialist ceilings and partitions including drylining, partitioning, suspended ceilings, screed, render, structural stud, plastering, GRG profiles and mouldings and Passive Fire Protection.

It is our policy to provide an efficient service to our customers within agreed timescales, following controlled procedures and a commitment to satisfy applicable requirements to both the ISO Standards and its customers.

Taylor Hart Ltd have established a Quality and Environmental Management System which will systematically document and control the procedures as necessary for the efficient operation of its business and provision of its service to its customers as contained within our Quality and Environmental Manuals and Quality and Environmental Plan in line with the requirements of ISO9001 : 2015 and ISO14001 : 2015.

The Quality, Environmental, Health and Safety Policy provides a framework for setting company objectives.

QUALITY

The aim of our management systems is to provide continual improvement and to ensure that :

- We deliver a quality service to maintain excellent customer relations.

The Quality and Environmental Management System and its effectiveness is reviewed at least annually and circulated throughout management (supervisor and above); amendments may be circulated as necessary should changing Company or legislative circumstances dictate. Site performance against the criteria laid down by the Quality and Environmental Manual is continually monitored during the site inspections regularly undertaken by senior management and the Safety, Health, Environmental and Quality Managers (SHEQ).

Taylor Hart's Quality and Environmental Plan and SHEQ Manual outline duties and responsibilities of the Company employees. The Controls for environmental issues is explained in the Environmental Management Plan.

Employees are made aware of their responsibilities to ensure minimal environmental impact from their activities.

HEALTH & SAFETY

Taylor Hart Limited is committed to preventing injury or ill health in the course of its everyday business to those affected by any associated hazardous processes or hazardous substances. Taylor Hart Limited is also committed to continually improving the management of health & safety through providing sufficient resources to eliminate significant risk and hazards or where elimination of risk is not possible, reduce and control residual risk and hazards.

Responsibilities.


